Nomination and application procedure:

Exchange students are only accepted based on a nomination by the home institution. Partner institution should send the nomination letter containing student's name, gender, field and level of study and planned duration of study period (semester or full academic year) and his/her e-mail address, as well as the other documents required by the receiving institution, to erasmuska1@ni.ac.rs

1. Applications/information on nominated students must reach the receiving institution by:

2. The receiving institution will send its decision within **4 weeks from the application deadline**.
3. A Transcript of Records with attendance dates will be issued by the receiving institution no later than **5 weeks after the assessment period** has finished at the receiving HEI. If the transcript is issued directly to the student, a scanned copy of the transcript of records will be sent to the international office of the sending institution.
4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
